In the desire for further development and mutual cooperation in the field of private security, all the listed participants or contractors which are convinced that such a cooperation will help to strengthen all-round relations between professional associations,

## **A G R E E:**

### **Article 1**

Mutual cooperation between all parties will be based on the expressed will to deepen relations, exchange professional expertise, information and support within the framework of national legislation.

### **Article 2**

The exchange of expertise, good practices and experience in the field of private security at international levels, mutual professional meetings and other forms of cooperation can be the basis for:

- preparation of national training and advanced training programs for security staff,
- development of new specialist training of security personnel,
- analysis of the situation at national level in the field of private security,
- preparation of project documentation or applying for various projects in the field of private security and
- promotion of private security at the level of the contractors.

### **Article 3**

The contracting parties within the limits of their possibilities and interests express their intention to exchange statistics and information in the field of private security on:

- security, safety and threat status,
- new forms and methods of committing criminal offenses,
- methods of protecting people and property,
- criminal offenses committed in connection with the provision of private security, and
- other circumstances affecting the system and the effectiveness of security and cooperation.

### **Article 4**

The contracting parties express their intention to support and assist each other within the possibilities of national legislation in various forms of professional and business cooperation for the members of their associations on the basis of reciprocity.

Article 5

The contracting parties undertake to monitor the implementation of the protocol and if necessary to propose amendments or modifications.

This protocol shall enter into force on the date of signature of all parties.
